If you do not agree to these rules, you must not apply for this Promotion. The Promoter reserves the right, acting reasonably, to disqualify applicants who do not comply with these rules.
2. **Who may apply:** Any person resident within South Africa or Namibia, over the age of 18 ("**Pet Parent**") and who receives the "*Welcome Kit*" code as detailed in clause 3 below. 3.2 Pet Parents will receive a code ("**Welcome Kit Code**") via SMS after entering their details as per clause 3.1 above, in order to receive a Welcome Kit. Included in the SMS will be a code ("**Welcome Kit Coupon**") for a saving of 25%, up to a maximum of R250 off on the purchase of any Hill's Science Plan puppy or kitten food or Prescription Diet i/d on a minimum spend of R200 - for puppies and/or kittens, which is valid for 5 (five) weeks from the date the coupon was sent.
